**Tender Notice and Invitation to Tender**

**NAMA-KHOI MUNICIPALITY** invites tenders for **TENDER NO: BOD/NC062/03/2021/2022: KOMAGGAS WATER SUPPLY PHASE 6b: EQUIPPING OF BOREHOLES IN BUFFELSRIVIER.**

The contract entails the following:

- Supply and installation of submersible pumps with all necessary pipe works and accessories
- Supply and installation of electrical control panels
- Construction of borehole supply pipeline
- Supply and delivery only of steel pipes including Victaulic couplings
- Electricity supply to boreholes
- Upgrading of telemetric control system
- Supply and installation of chlorination dosing equipment
- Dismantling of existing steel panel reservoir and removal from site
- Supply and installation of new 116kl galvanised steel panel reservoir

It is estimated that tenderers should have a CIDB contractor grading designation of **4ME** or higher.

A compulsory site visit/clarification meeting with representatives of the Employer and Engineer will take place at the **municipal service point in Buffelsrivier on Tuesday 15 February 2022 starting at 10h00**. Sealed tender documents appropriately marked with the contract number and name of the project, must be deposited in the tender box of Nama-Khoi Municipality, 4 Namakwa Street, Springbok, before **Friday, 04 March 2022 at 10:00**, where the tenders will be opened in public.

Facsimile, e-mail and late tenders will not be accepted.

The Municipality reserves the right not to award the tender to the only or the lowest Tenderer. Tenders may only be submitted on the tender documentation that has been issued.

No tender offer will be considered from the following tenderers:

- a) The tenderers must comply to the CIDB-Grading Conditions
- b) Persons who were convicted for fraud or corruption during the past five years.
- c) Who wilfully neglected, reneged on or failed to comply with a government contract during the past five years.
- d) Tenderer who cannot submit a valid Tax Clearance Certificate or SARS Pin.
- e) Tenderer who is not registered or accredited as a Contractor or a contractor according to the Central Contractor Database (CSD).
- f) Proof cannot be provided that a performance guarantee can be submitted on the award of the contract.
